

**COUNCIL OF THE BOROUGH OF WEST MIFFLIN** met in regular session in the Municipal Building Council Chambers on Tuesday, February 17, 2009 at 6:30 p.m. prevailing time with President William Welsh presiding.

**CITIZENS COMMENTS ON AGENDA ITEMS:**

**Diane Stanesic** of 2803 Glenny Lane Extension commented under the Approval of Minutes. She questioned whether citizens that comment on Agenda Items can obtain a copy of the Minutes before they are approved because some of the things she spoke on were not in the Minutes. She stated that she thinks that she should be able to look at them to make sure that what she said is accurately recorded. Mr. Bednar stated that they can be reviewed at the Administration Office before approval. Mr. Adams replied that the Minutes are unofficial until they are approved by Council and that it is not a regular practice in other communities. He said that it is Council's duty to review draft Minutes. Considerable discussion ensued and Mr. Olasz was ruled Out of Order for the third time and asked to leave the room. Mr. Olasz stated he was not leaving the room. Mr. Welsh requested that Chief Popovich escort Mr. Olasz from the room and Mr. Olasz refused and was ruled Out of Order for the fourth time. Mayor Andzelik intervened stating that he is against this action as he was in the past when previous Chief Diener had Mr. Olasz removed. Mr. Welsh reminded the Mayor that according to the ruling by Judge Ambrose when Mr. Olasz sued Mr. Welsh, he is not permitted to hijack the meeting. Mr. Stephenson stated that the past has been resolved by the courts and he recommended a five minute recess.

**Motion** by Stephenson, seconded by Popovich approving a five minutes recess. Under remarks, Mr. Welsh questioned whether a roll call vote is required. Mr. Adams stated that if there are no objections then there is no vote required.

**Meeting recessed at 6:45 p.m.**

**Mr. Welsh reconvened the Meeting at 6:55 p.m.**

Mr. Welsh stated that Mr. Olasz has been ruled Out of Order four times and it has been agreed upon by the six other members of Council that Mr. Olasz leave the meeting or the meeting would be adjourned. Mr. Olasz refused to leave the meeting and Mr. Welsh called for an adjournment.
