

ORDINANCE NO. 1156

ORDINANCE OF THE BOROUGH OF WEST MIFFLIN, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 5 – CODE ENFORCEMENT OF THE CODE OF ORDINANCES OF THE BOROUGH OF WEST MIFFLIN AND ORDINANCE NO. 1132 ENACTED JUNE 24<sup>TH</sup>, 2004 PROVIDING FOR THE ADOPTION OF THE SEVERAL AND VARIOUS 2006 BUILDING CODES

NOW, THEREFORE, BE IT ORDAINED and ENACTED BY Council of the Borough of West Mifflin at a meeting assembled as follows:

Section 1. Chapter 5 – Code Enforcement of the Code of Ordinances of the Borough of West Mifflin was amended with the passage of Ordinance No. 1132, enacted into law by Borough Council on June 14<sup>th</sup>, 2004. Ordinance No. 1132, Section 1, Part 1, Section 102 is hereby amended to adopt the following as part of the Pennsylvania Uniform Construction Code and Borough of West Mifflin Construction Code:

1. International Building Code/2006, including Appendix A through J.
2. International Residential Code/2006, including Appendix A through L
3. International Existing Building Code/2006
4. International Fire Code/2006
5. International Fuel Gas Code/2006
6. International Mechanical Code/2006
7. International Property & Maintenance Code/2006
8. International Code Council Performance Code/2006
9. International Private Sewage Disposal Code/2006
10. International Urban-Wildland Interface Code/2006
11. International Council Electrical Code/2006

Section 2. Section 302.4 of the International Property & Maintenance Code is amended to insert six (6) inches.

Section 3. Ordinance No. 1132 is amended to incorporate throughout the 2006 International Codes as outlined in Section 1 above

Section 4. The Uniform Construction Code, contained in 34 Pa. Code, Chapters 401-405, as amended from time to time is hereby adopted and incorporated herein by reference as the municipal building code of the Borough.

Section 5. That any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance be and the same are hereby repealed to the extent of such conflict.


Section 6. Severability. If any provision of this Ordinance is invalidated by any court of competent jurisdiction, the remaining provisions shall not be affected and shall continue in full force and effect.

Section 7. The effective date of this Ordinance shall be the thirty-first (31<sup>st</sup>) day from the enactment.
